Old Business

Laptop was reported to be working well had to get a new cord-Holding off on making a decision on the insurance due to the recent development with LCWC. Balloon festival have changes. We will now be working with Jake. Bruce is doing the stage area only. Jake said how we handle traffic is up to the task force. He is getting traffic cones and planning to cut out flagger force. Getting cones from T&W. Balloon Fest will be every year. We requested a porta potty. He will be bringing food around to ones working. Bought 2 canopies and he will put up a tent where flagger force was. Detouring traffic is up to us. Having insurance is more appealing to organizations and will be looking into that in the future. Hours for Balloon fest are Thursday 3pm to 10pm, Friday 3pm to 10pm, Saturday 11am to 11pm, Sunday 11am to 8pm. They paid \$8,000 last year and we are hoping to get atleast that this year. Luke looked into sand for canopies. 60 pound bag \$6.79 Motion for Luke to get what he needs for Balloon fest up to \$200 was made and approved. If Luke needs more come back and present it to the task force.

New Business

It was reported that Matt Shenk from LCWC will no longer dispatch the Fire police task force due to low call volume. County is to blame for low call volume. Fire Chief association not wanting fire police task force. May need to put something together to call officers in to help. They can request that company. How do we put that into simple method? Set up a signal to get

Police have the authority to call the task force. Mr Little is no better than any other Chief in this county. The task force will do more non-emergency events. Putting cancelation in minutes without notification is not correct procedure. Had to hear about this through the grapevine. Most Chief support the task force. Put a system in place. County commissioners' office may need to be contacted or get an attorney. Motion made and approved for folding cones not to exceed \$350
